
AR-110/2013::: In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in supersession of all recruitment rules notified prior to the notification* by Works Department, the Governor of Arunachal Pradesh hereby makes the following rules to regulate the method of recruitment to the posts of Executive Engineer, Group - 'A' (Non Ministerial) in the Department of PWD/Power/(Electrical)/RWD/IFC/ PHE & Water Supplies/Power (Civil) etc under the Government of Arunachal Pradesh, namely:-

1. **Short title and commencement :-** (1) these rules may be called "the Recruitment to the posts of Executive Engineer Rules'2014
(2) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.
2. **These rules shall apply to the posts as specified in column 1 of the schedule annexed to this rules.**
3. **Number of posts, classification and scale of pay :-** The number of posts, their classification and the Pay Band and Grade Pay /Pay Scale attached thereto shall be as specified in columns 2 to 4 in the Schedule aforesaid.
4. **Method of recruitment, age limit and other qualifications etc :-** The method of recruitment to the said post, age limit, qualifications and other matter relating thereto, shall be as specified in columns 5 to 13 of the Schedule aforesaid.
5. **Disqualification: -** No person,
(a) who has entered into or contracted a marriage with a person having a spouse living, or
(b) who having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said posts.

Provided that the Governor of Arunachal Pradesh may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing exempt any person from the operation of this rules.

6. **Power to relax: -** While the Governor of Arunachal Pradesh is of the opinion that it is necessary or expedient so to do, he may by order for reasons to be recorded in writing and in consultation with the Commission relax any of the provisions of these Rules with respect to any class or category of persons.
1. **Repeal & Savings: -** All rules and procedures corresponding to these rules and procedures in force immediately before the commencement of these rules are hereby repealed, provided that any order made or action taken under the rules so repealed shall be deemed to have been validly made or taken under the corresponding provisions of these Rules.

Nothing in these rules shall effect reservations/ relaxation of age limit and other concessions required to be provided for the Scheduled Castes and Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.


