NOTIFICATION

The 5th August, 2014

No. AR-03/2014.—In exercise of the powers conferred by the proviso to article 309 of the constitution of India and in supersession of all recruitment rules notified by various departments prior to this notification except in respect of things done or omitted to be done before supersession, the Governor of Arunachal Pradesh is pleased to make the following rules to regulate the method of recruitment to the post (s) of Draughtsman Grade-II, in various departments under the Government of Arunachal Pradesh, namely :—

1. **Short title and commencement :** (i) These rules may be called "the common Recruitment Rules to the post of Draughtsman Grade-II, 2014".
(ii) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.
2. **These rules shall apply to the posts as specified in column 1 of the Schedule Annexed to the rules.**
3. **Number of posts, classification and scale of pay :** The number of posts, their classifications and the Pay Band and Grade Pay/Pay Scale attached thereto shall be as specified in columns 2 to 4 in the Schedule aforesaid.
4. **Method of recruitment, age limit and other qualification :** The method of recruitment to the posts, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 13 of the Schedule aforesaid.
5. **Disqualification :** No person, —
 - (a) who has entered into or contracted a marriage with a person having a spouse living ; or
 - (b) who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for the appointment to the said post :

Provided that the Governor of Arunachal Pradesh may if satisfied that such marriage is permissible under the personal law applicable to such person and the other grounds for so doing, exempt any person for the operation of this rule.

6. **Power to relax :** Where the Governor of Arunachal Pradesh is of opinion that it is necessary or expedient so to do, he may by order for reasons to be recorded in writing and in consultation with the selection Board/Arunachal Pradesh Public Service Commission/Department of Administrative Reforms relax any of the provisions of these rules with respect to any class or category of person.

7. **Repeal and saving :** Nothing in these rules shall affect reservation/relaxation of age limit and other concessions required to provide for the Scheduled Caste and Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.

3.	Classification	— General Arunachal Service, Group 'C' Non-Gazetted (Non-Ministerial).
4.	Pay Band and Grade Pay/Pay Scale	— PB-2, ₹ 9,300-34,800 and Grade Pay ₹ 4,200 p.m.
5.	Whether selection post or non-selection post	— Not Applicable
6.	Age limit for direct recruits	Between 18 and 28 years of age.
7.	Educational and other qualification required for direct recruits.	— Minimum class X pass with 2 (two) years on Draughtsmanship from a recognized institution or Diploma in Civil Engineering.
8.	Whether age and educational qualification prescribed for direct recruits will apply in case of promotees	— Not applicable.
9.	Period of probation, if any	— 2 (two) years
10.	Method of recruitment whether by direct recruitment or by promotion or by deputation/absorption and percentage of the vacancies to be filled by various methods	— 50% by direct recruitment from the select list prepared on the basis of written competitive examination followed by viva-voce test as prescribed vide office memorandum No. OM-21/85 dated 28/08/2006 and No. 54/2006 dated 7/01/2006
11.	In the case of recruitment by promotion/deputation/absorption/grades from which promotion/absorption is to be made.	— 50% by promotion from amongst Draughtsman Grade-III of the department who have completed 5 (five) years of regular service in the grade.
12.	If a Departmental Promotion Committee exist what is its composition.	— (i) Commissioner/Secretary of the Department — Chairman (ii) One Secretary not connected with the Works of the Department — Member (iii) Head of Office — Member (iv) An APST Group 'A' Officer if none of the above members belong to APST — Member
13.	Circumstances in which the APPSC is to be consulted in making recruitment	— Consultation with the Commission as per the APPSC (Limitation of Function Regulations, 1998 as amended from time to time).
