

GOVERNMENT OF ARUNACHAL PRADESH

NOTIFICATION

Dated Itanagar, the 17th December '82.

In exercise of the powers conferred by the proviso Article 309 of the Constitution of India vide Govt. of India, Ministry of Home Affairs Notification No. U-14012/7/74-AP dated 7.4.76 (For Group A&B) the Administrator, Arunachal Pradesh is pleased to make the following Rules to regulate the method of Recruitment to Group 'B' Administrative officers posts in the various departments, Govt. of Arunachal Pradesh, Namely :-

1. Short title and commencement: (i) These rules may be called the (Group B posts) Recruitment Rules, 1982 (ii) They shall come into force on the date of publication in the Arunachal Pradesh Gazette.
2. These rules shall apply to the posts as specified in Col. I of the schedule annexured to the Rules.
3. Number of posts, classification and scale of pay:- The number of posts, their classification and the scale of pay attached thereto shall be specified in columns 2 to 4 in the schedule aforesaid.
4. Method of Recruitment, age limit and other qualification:- The method of Recruitment to the said posts age limit, qualification and other matters relating thereto shall be as specified in Columns 5 to 13 of the schedule aforesaid.
5. Disqualification :- No person.
 - (a) Who has entered into or contracted a marriage with a person having a spouse living ; or
 - (b) Who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for the appointment of the said posts, provided that the Administrator, Arunachal Pradesh may if satisfied that the such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are grounds for so doing, exempt any person from the operation of these rules.
6. Power to Relax:- Where the Administrator of Arunachal Pradesh is of opinion that it is necessary or expedient so to do, he may by order for reasons to be recorded in writing, and in consultation with Arunachal Pradesh Selection Board relax any of the provision of these rules with respect to any class or category of person.

7. Repeal and Saving:- All rules and procedures corresponding to these rules and procedures in force immediately before the commencement of these rules are hereby repealed provided that any order made or action taken under the rules repealed shall be deemed to have been validly made or taken under the corresponding provisions of these rules.

Nothing in these rules shall affect reservation/relaxation age limit and other concession required to be provided for the Schedule Caste/Schedule Tribe and other special categories or persons in accordance with the order issued by the Central Govt. from time to time in this regard.

This cancels the earlier Notification issued vide Memo of even number dated 7.10.1982.

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to make the following rules to regulate the method of recruitment to the post(s) of Administrative Officer in the various Department under the Government of Arunachal Pradesh, namely:-

1. **Short title and commencement:-**

- (i) These rules may be called "the Recruitment to the posts of Administrative Officers (Amendment) Rules, 2005.
- (ii) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.

2. **Amendment to the Schedule:** - In the Recruitment to the posts of (Group-B posts) Recruitment Rules, 1982 notified vide No.OM-12/79 dated 17-12-1982 against the existing provision of column 2, 4, 11, 12 & 13, the following shall be substituted, namely:-

- "1. **Column 2:** 24 (Twenty four) posts subject to variation dependent on work load.
2. **Column 4:** Rs.6500-200-10500/-PM.
3. **Column 11:** By promotion from Superintendent of the department with 5(five) years regular service in the grade.
4. **Column 12:** GROUP-B, DPC
 1. Commissioner/Secretary of the department. -Chairman.
 2. Commissioner/Secretary not connected with the work of the department. -Member.
 3. Head of Office. -Member.
 4. One Group 'A' APST officer if none of the Member belong to APST. -Member.
5. **Column 13:** As per the Arunachal Pradesh Public Service Commission (Limitation of Functions) Regulations, 1988 as amended from time to time".

3. **Repeal & Savings:-** On commencement of these rules, the Recruitment Rules for the post of Administrative Officer, in the Cultural Affairs Department, Library Wing as notified vide Notification No.CLB-8/2001 dated 27-4-2001 shall cease to operate.


