AR-134/2014:: In exercise of the powers conferred by the proviso to article 309 of the constitution of India and in supersession of all recruitment rules notified in the subject, prior to this notification except as respects things done or omitted to be done before such supersession, the Governor of Arunachal Pradesh is pleased to make the following rules to regulate the method of recruitment to the post(s) of "Upper division Clerk" Group "C" in various Departments under the Government of Arunachal Pradesh except Civil Secretariat/Assembly Secretariat/Governor Secretariat and Commissions, namely;-

1. **Short Title and commencement:-** (i) These rules may be called "the General Arunachal Pradesh Group 'C' (Ministerial) Common Recruitment (Amendment) Rules, 2015".

(ii) They shall be deemed to have come into force from 18/09/2014.

2. **Amendment of Schedule to the Rules:-**

(i) In the General Arunachal Pradesh Group C (Ministerial) Common Recruitment Rules, 2008 for the existing entries, the following shall be substituted, namely;-

a) the existing words "12 years" appearing in Column 12(ii) after the word "with" and before the words "regular" shall be substituted by the words "5 years".



No. AR-61/2007/521.— In exercise of the powers conferred by the proviso to article 309 of the constitution of India and in supersession of all recruitment rules notified in the subject, prior to this notification except as respects things done or omitted to be done before such supersession, the Governor of Arunachal Pradesh is pleased to make the following rules to regulate the method of recruitment to the post (s) of "Upper Division Clerk" Group "C" in various Departments under the Government of Arunachal Pradesh except Civil Secretariat/Assembly Secretariat/Governor Secretariat and Commissions, namely :-

1. **Short Title and commencement** :- (i) These rules may be called "the General Arunachal Pradesh Group 'C' (Ministerial) Common Recruitment Rules, 2008".

(ii) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.

2. **These rules shall apply to the posts as specified in column 1 of the Schedule Annexed to the Rules.**

3. **Number of posts, classification and scale of pay** :- The number of posts, their classifications and the scale of pay attached thereto shall be as specified in columns 2 to 4 in the Schedule aforesaid.

4. **Method of Recruitment, age limit and other qualifications** :- The method of recruitment to the posts, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 14 of the Schedule aforesaid.

5. **Disqualification** :- No person,

(a) who has entered into or contracted a marriage with a person having a spouse living or

(b) who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for the appointment to the said post.

6. **Power to relax** :- where the Governor of Arunachal Pradesh is of opinion that it is necessary or expedient so to do, he may by order for reasons to be recorded in writing and in consultation with the Selection Board relax any provisions of these rules with respect to any class or category or person.

7. **Repeal and saving** :- All rules and procedures corresponding to these rules and procedures in force immediately before the commencement of these rules are hereby repealed, provided that any order made or action taken under the rules so repealed shall be deemed to have been validly made or taken under the corresponding provisions of these rules.

Nothing in these rules shall effect reservation/relaxation of age limit and other concessions required to provide for the Scheduled Castes and Schedule Tribes and other special categories of persons in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.

No.AR-68/2009:: In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to make the following rules further to amend the General Arunachal Pradesh Group 'C' (Ministerial) Common Recruitment Rules, 2009 in so far as they relate to the post of Upper Division Clerk under the Government of Arunachal Pradesh except Civil Secretariat/Assembly Secretariat/Governor Secretariat, District and Subordinate Courts and Commissions, namely :-

1. Short title and commencement :- (1) These rules may be called the **General Arunachal Pradesh Group-'C' (Ministerial) Common Recruitment (Amendment) Rules, 2009.**

(2) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.

2. In the General Arunachal Pradesh Group-C (Ministerial) Common Recruitment Rules 2008, -

(i) in rule (3) and the Schedule annexed to the rules in column(4), for the word "scale of pay" the words "Pay Band and Grade pay/Pay Scale shall be substituted.

(ii) In the Schedule,--

(a) for the Entries in Column 4, the entries "Pay Band -Rs.5200-20,200/-, Grade Pay Rs.2800"- shall be substituted.


