NOTIFICATION

The 17th March, 2008

No. AR-61/2007/521.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in supersession of all recruitment rules notified in the subject, prior to this notification except as respects things done or omitted to be done before such supersession, the Governor of Arunachal Pradesh is pleased to make the following rules to regulate the method of recruitment to the post(s) of "Lower Division Clerk" Group "C" in various Departments under the Government of Arunachal Pradesh except Civil Secretariat/ Assembly Secretariat/Governor Secretariat and Commissions, namely :—

- Short title and commencement :** (i) These rules may be called "the General Arunachal Pradesh Group-'C'(Ministerial) Common Recruitment Rules, 2008".
(ii) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.
- These rules shall apply to the posts as specified in column 1 of the Schedule Annexed to the Rules.
- Number of posts, classification and scale of pay :** The number of posts, their classification and scale of pay attached thereto shall be as specified in columns 2 to 4 in the schedule aforesaid.
- Method of recruitment, age limit and other qualifications :** The method of recruitment to the posts, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 14 of the Schedule aforesaid.
- Disqualification :** No person, —
 - who has entered into or contracted a marriage with a person having a spouse living ; or
 - who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for the appointment to the said posts :
- Power to relax :** Where the Governor of Arunachal Pradesh is of opinion that it is necessary or expedient so to do, he may, by order for reasons to be recorded in writing and in consultation with the Selection Board relax any of the provisions of these rules with respect to any class or category of person.
- Repeal and saving :** All rules and procedures corresponding to these rules and procedures in force immediately before the commencement of these rules are hereby repealed, provided that any order made or action taken under the rules so repealed shall be deemed to have been validly made or taken under the corresponding provisions of these rules.

Nothing in these rules shall affect reservation/relaxation of age limit and other concessions required to provide for the Scheduled Caste and Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.

No.AR-67/2009::In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to make the following rules further to amend the General Arunachal Pradesh Group 'C' (Ministerial) Common Recruitment Rules, 2009 in so far as they relate to the post of Lower Division Clerk under the Government of Arunachal Pradesh except Civil Secretariat/Assembly Secretariat/Governor Secretariat, District and Subordinate Courts and Commissions, namely :-

1. Short title and commencement :- (1) These rules may be called the **General Arunachal Pradesh Group-'C' (Ministerial) Common Recruitment (Amendment) Rules, 2009.**

(2) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette

(i) in rule (3) and the Schedule annexed to the rules in column(4), for the word "scale of pay" the words "Pay Band and Grade pay/Pay Scale shall be substituted.

(ii) In the Schedule,--

(a) for the Entries in column 4, the entries "Pay Band -Rs.5200-20,200/- ,Grade Pay Rs.1900"- shall be substituted.



No.AR-32/2012:: In exercise of the powers conferred under the section 309 of the Constitution, the Governor of Arunachal Pradesh is pleased to make the following rules further to amend the General Arunachal Pradesh Group-'C' (Ministerial) Common Recruitment Rules, 2008 so far as they relate to the post of "Lower Division Clerk" under the Government of Arunachal Pradesh except Civil Secretariat/Assembly Secretariat/Governor Secretariat, District and Subordinate Courts and Commissions, namely :-

1. **Short title and commencement** :- (1) These rules may be called the General Arunachal Pradesh Group-'C' (Ministerial) Common (Amendment) Recruitment Rules, 2012.

(ii) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.

(2) **Amendment of Schedule to the Rules** :-

(i) the column (7) of the Schedule in Rules shall be deleted.

(ii) for the existing entries in column (8), the following shall be substituted namely:

(a) 12th Class pass or equivalent qualification from a recognized Board or Institution.

(b) a typing speed of 30 words per minute in English on manual typewriter or typing speed of 35 words per minute on Computer" (35 w. p. m corresponds to 10500 Key Depression per hour (KDPH) on an average of 5 key depression for each word).

(c) 10 % of the vacancies shall be filled from amongst Group-C staff in the Grade Pay of Rs.1800 and who possesses 12th class pass or equivalent qualification and a typing speed of 30 words per minute in English on manual typewriter or typing speed of 35 words per minute on Computer" (35 w .p. m corresponds to 10500 Key Depression Per Hour (KDPH) on an average of 5 key depression for each word) and have rendered 3 years of regular service in the grade, on the basis of the merit adjudged through departmental qualifying examination".


