NOTIFICATION

Dated, Itanagar the 8th February,2011.

NO.AR-133/10¹¹¹: In exercise of the powers conferred by the proviso to article 309 of the constitution of India, and in supersession of the , Arunachal Pradesh Public Service Commission Stenographer Grade-III(Group-C) Recruitment Rules, 1993, except as respect things done or omitted to be done before such supersession the Governor of Arunachal Pradesh is pleased to make the following rules to regulate the method of récrutment to the post(s) of Personal Assistant, Arunachal Pradesh Public Service Commission, namely:-

1. **Short Title and commencement:-** (1) These rules may be called the Personal Assistant(Arunachal Pradesh Public Service Commission, Group-C, Non-Gazetted, ministerial) Recruitment Rules,2011.
(2) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.
2. **These rules shall apply to the posts as specified in column 1 of the Schedule Annexed to the Rules.**
3. **Number of posts, classification and Pay Band/Grade Pay/Pay Scale:-** The number of posts, their classifications and the Pay Band/Grade pay/Pay Scale attached thereto shall be as specified in column 2 to 4 in the Schedule aforesaid.
4. **Method of Recruitment, age limit and other qualifications:-**
The method of recruitment to the posts, age limit, qualifications and other matters relating there to shall be as specified in columns 5 to 14 of the Schedule aforesaid.
5. **Disqualification: -** No person.
(a).who has entered into or contracted a marriage with a person having a spouse living or
(b). who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for the appointment to the said post.
Provided that the Governor of Arunachal Pradesh may, if satisfied that such marriage is permissible under the personal Law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.
6. **Power to relax: -** where the Governor of Arunachal Pradesh is of opinion that it is necessary or expedient so to do, he may by order for reasons to be recorded in writing and in consultation with the Selection

Board relax any provisions of these rules with respect to any class or category or person.

7. **Repeal and saving:** The Stenographer Grade-III(Group-C) Recruitment Rules notified vide notification No.OM-4/93 dated 12.08.1993 is hereby repealed. Provided that any order made or action taken under the rules so repealed shall be deemed to have been validly made or taken under the corresponding provisions of these rules. Nothing in these rules shall effect reservation/ relaxation of age limit and other concessicns required to provide for the Scheduled Caste and Schedule Tribes and other special categories of persons in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.


