NOTIFICATION

The 5th February, 2007

No. OM--98/2006.—In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, and in supersession of all recruitment rules notified prior to this notification, except as respects things done or omitted to be done before such supersession, the Governor of Arunachal Pradesh is pleased to make the following rules to regulate the method of recruitment to the post(s) of "Driver" Group "C" in all Departments under the Government of Arunachal Pradesh except Police, Fire Service, Jail Service and State Transport, namely:—

1. **Short title and commencement:** (i) These rules may be called "the General Arunachal Pradesh Group 'C' Driver (Non-Gazetted, Non-Ministerial) Recruitment Rules, 2006".

(ii) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.

2. These rules shall apply to the posts as specified in column 1 of the schedule Annexed to the Rules.

3. **Number of posts, classification and scale of pay:** The number of posts, their classifications and the scale of pay attached thereto shall be as specified in columns 2 to 4 in the Schedule aforesaid.

4. **Method of Recruitment, age limit and other qualifications:** The method of recruitment to the posts, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 14 of the Schedule aforesaid.

5. **Disqualification:** No person, —

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for the appointment to the said post.

Provided that the Governor of Arunachal Pradesh may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

6. **Power to relax:** Where the Governor of Arunachal Pradesh is of opinion that it is necessary or expedient so to do, he may by order for reasons to be recorded in writing and in consultation with the Selection Board relax any provisions of these rules with respect to any class or category or person.

7. **Repeal and Saving:** All rules and procedures corresponding to these rules and procedures in force immediately before the commencement of these rules are hereby repealed, provided that any other made or action taken under the rules so repealed shall be deemed to have been validly made or taken under the corresponding provisions of these rules.

Nothing in these rules shall effect reservation/relaxation of age limit and other concessions required to provide for the Scheduled Castes and Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.

No. AR-70/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Arunachal Pradesh hereby makes the following rules to amend the General Arunachal Pradesh Group 'C' Driver (Non-Gazetted), (Non-Ministerial) Recruitment Rules, 2006 in all departments under the Government of Arunachal Pradesh, except Police, Fire Services, Jail Services and State Transport namely :

1. **Short title and commencement :** (1) These rules may be called "General Arunachal Pradesh Service Group-C Driver, (Non-Gazetted), (Non-Ministerial), (Amendment) Recruitment Rules, 2009.
2. In the General Arunachal Pradesh Group 'C' (Non-Gazetted), (Non-Ministerial) Recruitment Rules, 2006.
 - (i) in rule (3) and the Schedule annexed to the rules in column (4), for the words "scale of pay", the words "Pay Band and Grade Pay/Pay Scale" shall be substituted.
 - (ii) In the schedule :
 - (a) for the entries in column 4, the entries "Pay Band-Rs. 5200-20,200 and Grade Pay - Rs. 1900" shall be substituted.
 - (b) for the entries in column 8 ; the entries under column heading 'Light Motor Vehicle Driver' and 'Heavy Motor Vehicle Driver' in clauses (i) and (ii), relating to the educational qualifications required for the said post, the entries "Possessing Matriculation or its equivalent qualification" shall be accordingly substituted.
