No. OM-118/2006.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in supersession of all recruitment rules notified prior to notification of this rules, except as respect things done or omitted to be done before such supersession, the Governor of Arunachal Pradesh is pleased to make the following rules to regulate the method of recruitment to the post(s) of Duftry, Group "D" post(s) in all the departments/offices under the Government of Arunachal Pradesh as in the schedule annexed namely :-

1. **Short title and commencement** : (i) These rules may be called Duftry, Group "D" Recruitment Rules 2008.

(ii) They shall come into force on the date of their publication in the Gazette.

2. These rules shall apply to the post(s) as specified in column 1 of the schedule Annexed to the Rules.

3. **Number of post(s), classification and scale of pay** : The number of post(s), their classifications and the scale of pay attached thereto shall be as specified in columns 2 to 4 in the schedule aforesaid.

4. **Method of recruitment, age limit and other qualifications** : The method of recruitment to the posts, age limit, qualifications and other matters relating thereto, shall be as specified in columns 5 to 14 of the schedule aforesaid.

5. **Disqualification** : No person, —

(a) who has entered into or contracted a marriage with a person having a spouse living ; or

(b) who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for the appointment to the said post :

Provided that the Governor of Arunachal Pradesh may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of these rules.

6. **Power to relax** : Where the Governor of Arunachal Pradesh is of opinion that it is necessary or expedient so to do, he may by order for reasons to be recorded in writing and in consultation with the Selection Board/Arunachal Pradesh Public Service Commission relax any of the provisions of these rules with respect to any class or category or person.

7. **Repeal and saving** : All rules and procedures corresponding to these rules and procedures in force immediately before the commencement of these rules are hereby repealed, provided that any order made or action taken under the rules so repealed shall be deemed to have been validity made or taken under the corresponding provision of these rules.

Nothing in these rules shall affect reservation/relaxation of age limit and other concessions required to provide for the Arunachal Pradesh Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.

No.AR-85/2009::In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to make the following rules further to amend the General Arunachal Pradesh Group 'D'(Non-Ministerial) Common Recruitment Rules,2009 in so far as they relate to the post of Daftry under the Government of Arunachal Pradesh, namely :-

1. Short title and commencement :- (1) These rules may be called the **General Arunachal Pradesh Daftry Group-'C' (Non-Ministerial) Common Recruitment (Amendment) Rules,2009.**

- (2) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette
- (i) in rule (3) and the Schedule annexed to the rules in column(4),for the word "scale of pay" the words "**Pay Band and Grade pay/Pay Scale**" shall be substituted.
- (ii) In the Schedule:-
- (a) for the Entries in column 3,the entries "**Group -C**" shall be substituted.
- (b) for the Entries in column 4,the entries "**Pay Band -Rs.5200-20,200/- ,Grade Pay Rs.1800**"- shall be substituted.
- (c) for the Entries in column 8,the entries "**matriculation/ITI /equivalent**" shall be substituted.
