The Arunachal Pradesh District Based Entrepreneurs and Professional (Incentives, Development and Promotional) Act,2015 shall be enforced.

1. The prospective bidders should be registered contractors domiciled within the territorial jurisdiction of 53-Changlang (North) Assembly constituency as per **Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentives, Development and Promotional) Act, 2015.**
2. The prospective bidders should have experience of total work execution of similar nature of work not less than 40% of the amount put to tender in last 3 (three) years .
3. Income tax and GST clearance certificate for the previous tax period duly issued by competent authority
4. PAN & GST registration from the competent authority of Arunachal Pradesh/Central Government.
5. Rates quoted should be inclusive of applicable taxes, royalties, labour cess etc.
6. Payment shall be subject to availability of specific fund/LoC against the work.
