The Executive Engineer(E), Aalo Electrical Division, Department of Power, Aalo District West Siang Arunachal Pradesh on behalf of the Governor of Arunachal Pradesh invites item rate tender in single bid envelope system from Contractors registered in Class- C & above under Electrical (Supply & Erection) category domiciled within the territorial jurisdiction 27<sup>th</sup> Liromoba Assembly Constituency of West Siang District, Arunachal Pradesh and registered under Arunachal Pradesh District based Entrepreneurs and Professionals (Incentives, Development and Professional) Act 2020 vide NO.LAW/LEGN-23/2020 Dated 2<sup>nd</sup> November 2020 for work as stated below :-

1. The Arunachal Pradesh District Based Entrepreneurs and Professionals (INCENTIVE, DEVELOPMENT AND PROMOTIONAL) ACT, 2020 shall be applicable.

2. Criteria for eligibility for issue of tender documents:-

- 2.1 Tender documents will be issued to eligible Power registered contractors provided they produce proof of registration/enlistment from the competent authority of Department of Power which shall be to the satisfaction of competent authority.
- 2.2 Copy Valid GST Registration, PAN Card, Latest Income Tax Clearance Certificate from the competent authority.
- 2.3 Permanent Residential Certificate, Aadhar Card, Voter ID card issued by the competent authority to be submitted as proof of being the domicile within the territorial jurisdiction of Assembly Constituency to participate in the tender in pursuance to the Arunachal Pradesh District Based Entrepreneur and Professionals (INCENTIVE, DEVELOPMENT AND PROMOTIONAL) ACT, 2020.
- 2.4 Letter of authority and proof of being authorized representative of the bidder.  
Tender documents consisting of plans, specifications, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the contractor whose tender may be accepted and other necessary documents can be seen in the office of the Executive Engineer (E), Aalo Electrical Division between hours of 1000 Hours to 1600 Hours from 19/03/2026 to 23/03/2026 every day except on Sundays and Public Holidays.

Tender document will be issued from this office during the hours specified above on payment of the cost of tender paper in cash being the cost of the tender document which is no refundable.

3. The intending tenderer shall have to apply for the tender document in Contractor's/Company's printed letter pad with detail postal address, Telephone, Mobile & Fax and E-mail ID, etc.
4. Tenders, which should always be placed in sealed envelope with the name of work and due date written on the envelopes, will be received by the Executive Engineer (E), Aalo Electrical Division, Aalo up to 1200 Hours on 24/03/2026 and will be opened by him/her or his/her authorized representative in his/her office on the same day from 1500 Hours.
5. Tender must be accompanied by Earnest Money in the form of deposit at TDS/Demand Draft of a Nationalised Bank issued in favour of Executive Engineer (E), Aalo Electrical Division. The Earnest money has to be valid for 90 days beyond the validity of the Tender. The Tender without Earnest Money shall be rejected.
6. The tender paper shall neither be sold nor be accepted for opening through postal or courier services.
7. The Department shall not take responsibility for any form of delay in receiving the tender papers in time and no extension of time shall be entertained on such account. Tender papers received after due date or time of submission will not be accepted under any circumstances.
8. The Department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.


